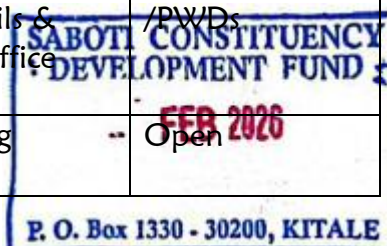

Bids must not be submitted electronically but delivered physically to the NG-CDF Office Building, Trans Nzoia County Commissioner's Compound, on or before **Thursday, 5th March 2026 at 10:00 a.m.** and will be opened immediately thereafter in the presence of bidders or their representatives who choose to attend.
